OCA CIRCULAR NO. 100 - 2020

- TO** : ALL LITIGANTS, CONCERNED JUDGES AND COURT PERSONNEL OF THE FIRST AND SECOND LEVEL COURTS, AND MEMBERS OF THE BAR
- RE** : ADDITIONAL COURTS AUTHORIZED FOR PILOT-TESTING OF HEARINGS THROUGH VIDEOCONFERENCING

Considering that videoconferencing hearings shall proceed as provided by Administrative Circular No. 41 - 2020, there is a need to authorize more courts to pilot-test the videoconferencing hearings.

Accordingly, upon approval of Chief Justice Diosdado M. Peralta, the following additional court stations are herein authorized to pilot-test hearings through videoconferencing during this public health emergency:
